Modalities for Minor Research Project

1. According to UGC, the name of "Research Committee" may change to "Research Advisory Committee" (RAC).
2. The members of the Research Advisory Committee, who is applying for Minor Research Project (MRP) ceased to function as member of RAC for the time being.
3. Major Notes:
 - a. No Project Assistant will be provided for MRP.
 - b. The project should be approved by the Research Advisory Committee & external subject expert.
 - c. The Project In-charge (PI) should submit the MRP within one year from the date of award.
 - d. Govt. (Auto.) College will felicitate the PI with a certificate after successful completion of the project.
 - e. A separate portal (Research Bulletin) will be launched by the GACR for displaying the research outcomes from the MRP.
 - f. The PI should publish one paper from the MRP in unpaid UGC Care/Scopus/SCI/ Web of Science/ABS/ABDC etc. or should present a paper in a reputed International Conference. Collaborative work is appreciated subject to the PI will be positioned him/herself either as "First Author" or "Corresponding Author".
 - g. The MRP should be submitted to the RAC in a hard bound form & CD.
 - h. Project proposal should not be exactly equal as the Ph.D. thesis & Post Doctoral thesis.
 - i. The detailed MRP will be checked thoroughly through Turnitin/Ithinticate or any Plag-check software.
 - j. Matrices and citations used in the MRP should be as per APA/ CHICAGO/ OXFORD/ MLA/ HAVARD.

- k. For selecting the MRP, priorities should be given to the ideas which is unique in nature.
- l. If the PI fails to submit the detailed MRP with the necessary publications or conferences within the stipulated time frame, the sanctioned amount must be recovered or returned back to the college.
- m. Six Months progress report will be submitted to RAC & any additional suggestion proposed by RAC will be incorporated.
- n. 60 % of the sanctioned amount will be released immediately and rest 40 % will be released after the successful submission of six months progress report of MRP.
- o. PIs may take necessary suggestions from RAC, if needed.
- p. Books / Journals / Equipment and software procured from MRP fund will be treated as college property.
