(Please note that the student is not required to print & sign it as it used to be in the earlier case).



Minutes of Anti Ragging Cell meeting held on 28.10.2024

A meeting of Anti Ragging Cell was held on 28.10.2024 at 3:30 P.M in the Principal's chamber under the Chairmanship of Sri P.K. Sethy, Asst. Prof. of Stat. and Administrative Bursar regarding Ragging **complaint No. OD_0149**

The matters were discussed and unanimously resolved the following.

1. The Committee failed to reach in final decision and decided to forward the above-mentioned ragging case to the Police Station, Raghunathpali, Rourkela for investigation and necessary action in this regard due to the below mentioned reasons.

- Tushar Kanta Tandî, Roll No. 22ENG-005, S/o Amin Tandî, Qrs. No. G/121, Sector-19, Rourkela-769005 (the victim of the Case) filed a complaint to Anti Ragging Helpline, UGC on 04.09.2024. When he was called for counselling, he did not appear. It was almost after 45 days of the complaint he submitted an application for withdrawal of the complaint mentioning the incident was a misunderstanding.
- Another victim named Poojarani Sahu, Roll No. 23PENG-022, Qrs No. H/194, Sector-06, Rourkela-769002 complained of violation of Fundamental Rights under Article-21 in her complaint to Anti Ragging Helpline, UGC on 12.09.2024. In the same complain she also mentioned that the Head of the Institution is a regular violator & manipulator of laid guidelines of the constitution and is unsafe for victims. Hence, the matter needs to be investigated by an outside agency for reasonable outcome. She also complained that the Anti Ragging Cell of this college called the victim Tushar Kanta Tandî not for counselling but for ragging.

Again on 26.10.2024, Poojarani Sahu gave a letter through email to provide the status report of the complaint on violation of her fundamental rights under Article-21 which needs legal competency.

- The following 04(four) accused gave in writing on 12.09.2024 that the complaint filed against them is baseless and false and that they are innocent.
 - Sanjana Day, Roll No. 22ENG-029, D/o Sanjay Kumar Dey, back side of Saraswati Sishu Vidya Mandir, Kuarmunda, Dist: Sundargarh-770039.
 - Swayamsidha Mohanty, Roll No.22ENG-041, D/o Subrat Mohanty, At: TT/15, Civil Township, Rourkela-769004.
 - Kapil Kumar Jit, Roll No.22ENG-030, S/o Dologobinda Jit, At: Indrapur, Raiboga, Dist: Sundargarh-770033.
 - Karan Safi, Roll No. 22ENG-037, S/o Sanjay Safi, At: Kansabahal, Rajgangpur, Sundargarh-770034

They also explained before the cell in the meeting dated 13.09.2024 that they did not force the victim (Tushar Kanta Tandî) to record a call made by him to a Senior Girl Student and also not insisted him to play the recorded call before them.

Minutes of Anti Ragging Cell meeting held on 13.09.2024.

A meeting of Anti Ragging Cell was held on 13.09.2024 at 3:00 P.M under the Chairmanship of the Principal, Govt. Auto. College, Rourkela, Dr. B. K. Behera. in the Principal's chamber regarding complaint of ragging received from UGC Net Bureau. The matters were discussed and unanimously resolved the following.

Regarding Ragging complaint No. OD_0149:

1. Sanjana Dey, Roll No. 22ENG029, Karan Safi, Roll No. 22ENG037, Swayamsidha Mohanty, Roll No. 22ENG041, Kapil Kumar Jit, Roll No. 22ENG030 appeared before the Cell and explained the facts of allegation made against them.

They also explained that they did not force the victim who is their batchmate to record a call made by him to a senior girl student and also not insisted him to play the recorded call before them.

Accused Karan Safi submitted a call record of conversation between him and the victim Tushar Kanti Tandy in which Sri Tandy threatened.

Further Karan Safi submitted a screen short of letter issued by Poojarani Sahu, Seminar Secretary, PG Dept. of English regarding collection of onetime fees of Rs. 1000/- (one thousand only) for every event from UG & PG Students.

All the above mentioned accused submitted a clarification of complaint of ragging made against them addressed to HoD English.

A letter was issued to the victim to appear before the Anti Ragging Cell for counselling, but because of his health issues and unsafe feeling, he expressed his inability through email to appear physically.

2. In this regard the cell wants to listen the facts from the victim to take final decision. So, the victim shall be called upon to appear before the Anti Ragging Cell. A letter in this regard will be issued to the victim to intimate a date of his appearance as per his convenience from a window of 07 days.

3. The Anti Ragging Cell found that another victim Poojarani Sahu submitted a complaint of ragging along with a copy of complaint regarding physical abuse to Anti Ragging Help Line, UGC Net Bureau on 12.09.2024.

Further, the cell received through email from UGC Net Bureau the copy of both the complaint of ragging and physical abused submitted by Poojarani Sahu to UGC, Net Bureau.

Hence, the cell decided to forward the copy of complaint of physical abused of Poojarani Sahu to Internal Compliance Committee of this college for necessary action at the earliest.

4. Anti Ragging Cell issued a letter to HoD, English on 04.09.2024 for detail investigation regarding the complaint of ragging received from UGC Net Bureau vide Complaint No. OD_0149. HoD English submitted the investigation report to the Chairman, Anti Ragging Cell on 11.09.2024. From the report the cell realised that the report contains only an allegation against the authority and no fact regarding the matter.

Hence, the cell decided to investigate the matter again to reach on final decision.







- (6) Declaration of intent in the College Prospectus and website as per UGC guidelines
- (7) Meetings by Principal with various functionaries/agencies
- (8) Display of names and contact number of members of Anti Ragging committee and Anti Ragging Squad.
- (9) Video – show of Anti Ragging Documentary from UGC Website for all the students
- (10) Anti-Ragging Sensitization programmes
- (11) Guest Lecture on 'Eve-Teasing'

(1) Constitution of Antiragging Committee in the College :-

In order to ensure strict compliance and monitoring of Anti Ragging measures as laid down in UGC Regulation, college will nominat the following representatives-

- (1) Head of the Institution/College
- (2) Representative of Police Administration
- (3) Representative of Police Local Media
- (4) Representative of Faculty members (4 in numbers)
- (5) Representative of Parents
- (6) Representative of Students
- (7) Representative of Non-teaching

(2) Constitution of Antiragging Squad :-

1. Principal
2. Academic Bursar
3. Examination Controller
4. IQAC Coordinator
5. Superintendent of all the Boys Hostel and Girls Hostels

(3) Affidavit by Student

In order to ensure strict compliance and monitoring of anti-ragging measures and make students aware of the prohibition of ragging and the punishment. Prescribed, both under penal as well as under the UGC Regulations and also affirm to the effect that he/she has not been expelled and or debarred by any institution and further aver that he/she would not indulge, actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/ or abetting ragging liable to be proceeded against under these regulation and / or under any penal Law or any other Law for the time being in force, college has obtained the affidavit from students while seeking admission to the college at every academic year.

(4) Affidavit by Parents :-

In order to achieve the objective & as laid down in the UGC Regulations for curbing the menace of ragging, college will obtain affidavit from parents/guardians of students also, duly signed by the concerned parents/ guardians of the applicant to the effect that he/she has read and understood the provisions of these regulations with same effect as laid down in the affidavit by students.

(5) Declaration of intent in the college prospectus:-


In view of drawing the attention of the prospective students for admission with regard to any Law concerning ragging and its consequences college has declared its intent in the prospectus of every academic year. While students registering their admission they are informed that ragging is totally prohibited in the college / institution, and /or abetting ragging, is liable to be punished –in accordance with these regulations as well as under the provisions of any penal Law for the time being in force.

(6) Meetings by Principal with various functionaries/ agencies :-

For curbing the menace of ragging, the principal of the college, will conduct meeting of various functionaries/agencies', such as Hostel Wardens, representatives of students, parents/ guardians, faculty, district administration including the police, to discuss the measures to be taken to prevent ragging in the college/ institution and steps, to be taken to identify those including or abetting ragging and punish them.

(9) Display of names and contact numbers of members of 'Anti-Ragging Committee and Anti Ragging Squad':-

The names and contact numbers of Members of the Anti Ragging Committee to be displayed at the college website which is conspicuous to all students.
